

GOVERNMENT NOTICE NO. 66

THE CONSTITUTIONAL REVIEW ACT

(No. 8 of 2011)

NOTICE

(Made under section 6)

WHEREAS, subsections (1) and (2) of section 6 of the Constitutional Review Act, 2011 vest in the President powers, upon consultation and agreement with the President of Zanzibar and having regard to the principle of equal members from either part of the United Republic, to appoint the Chairman, Vice-Chairman and not less than twenty and not more than thirty other members of the Commission in accordance with section 7(1);

AND WHEREAS, in appointing members of the Commission the President is bound to have regard to:

- (a) experience relevant to constitutional review or professional

- qualifications on constitutional matters, law, public administration, economic, finance and social science;
- (b) geographical and the population diversity of the United Republic of Tanzania; and
 - (c) age, gender and representation of various social groups;

AND WHEREAS, subsections (4) and (5) of section 6 provides that a person shall not qualify for appointment as a member of the Commission unless that person is of high integrity and impeccable behaviour and is not a member of security organs or a non-citizen of Tanzania;

AND WHEREAS, subsection (6) of section 6 requires the President to invite fully registered political parties, religious organisations, civil societies, associations, institutions and any other group of persons under whatever name having common interest to submit to the President a list of names of persons for appointment as members which list shall indicate the age, gender, experience, qualifications and place of abode of each of such persons;

AND WHEREAS, the President is minded to appoint members of the Commission as provided for in the law;

NOW THEREFORE, I, JAKAYA MRISHO KIKWETE, the President of the United Republic of Tanzania, DO HEREBY, in terms of section 6(6) of the Constitutional Review Act, 2011, issue the following notice:

1. This Notice may be cited as the Constitutional Review (Invitation of Lists of Names) (Members of the Commission) Notice, 2012.

- 2.-(1) Notice of invitation is hereby given to fully registered political parties, religious organisations, civil societies, associations, institutions and any other group of persons under whatever name having common interest to submit to the President a list of names of persons for appointment as members of the Commission.
 - (2) The list of names submitted in terms of subparagraph (1), shall contain not more than three names of persons and shall indicate the age, gender, experience, qualifications and a place of abode of each of the persons listed.

3. The period during which a list of names shall be submitted to the President in terms of paragraph 2, shall be twenty-one days running from the 25th day of February, 2012 and shall expire on the 16th day of March, 2012.
