## The Republic of the Union of Myanmar Law for the Second Amendment of the Constitution of the Republic of the Union of Myanmar (The Pyidaungsu Hluttaw Law No. \_\_\_\_, 2019) The \_\_\_\_\_ Waning/Waxing of \_\_\_\_\_, 1380 M.E. ( th \_\_\_\_\_, 2019)

The Pyidaungsu Hluttaw hereby enacts this Law.

1. This Law shall be called the **Law for the Second Amendment of the Constitution of the Republic of the Union of Myanmar**.

2. The phrase "from among the Region or State Hluttaw representatives or from among persons who are not Hluttaw representatives concerned" in Sub-Sub-Article (a) (i) of Article 262 of the Constitution of the Republic of the Union of Myanmar shall be deleted.

3. The phrase "obtain a list of Chairpersons" in Sub-Sub-Article (a) (iii) of Article 262 shall be replaced with "obtain and present to the President a list of Chairpersons".

- 4. Sub-Article (e) of Article 262 shall be replaced with the following.
  - (e) The Chief Minister of the Region or State shall appoint, as the Ministers of the Region or State, persons who are approved by the Region or State Hluttaw or persons who are on the list of Hluttaw Representatives elected to undertake the affairs of National races.
- 5. Sub-Article (f) of Article 262 shall be replaced with the following.
  - (f) In appointing Ministers of the Region or State, the Chief Minister shall, in co-ordination with of the Hluttaw concerned, designate the Ministry or Ministries which each Region or the State Minister is to take responsibility.
- 6. Sub-Article (j) of Article 262 shall be replaced with the following.
  - (j) The Chief Minister of the Region or State may, if he so wishes, assign the Defence Services personnel as the Region or State Ministers for other duties apart from security and border affairs, after obtaining their list from the Commander-in-Chief of the Defence Services, with the approval of the Region or State Hluttaw concerned.
- 7. Sub-Article (k) of Article 262 shall be replaced with the following.
  (k) The President shall intimate the appointments of the Chief Minister and Ministers of the Region or State to Pyidaungsu Hluttaw and the Region or State Hluttaws concerned. The Chief Minister shall intimate the appointments of the Ministers of the Region or State to the Region or State Hluttaw concerned and present such to the President.
- Sub-Sub-Article (l) (ii) of Article 262 shall be replaced with the following.
   (ii) The Ministers of the Region or State shall be responsible to the Chief Minister of the Region or State concerned.
- 9. Sub-Article (a) of Article 264 shall be replaced with the following.





- (a) The Chief Minister or any Minister of the Region or State may resign from office on his own volition due to a certain reason before expiry of the term of office, after submitting his written resignation respectively to the President for the former or to the Chief Minister for the latter.
- 10. Sub-Article (c) of Article 264 shall be replaced with the following.
  - (c) If the office of the Chief Minister or Ministers of the Region or State becomes vacant due to resignation, removal from office, death or any other reason, the President shall have the right to appoint and assign duties to a new Chief Minister of the Region or State, and the Chief Minister shall have the right to appoint and assign duties to new Ministers of the Region or State, in accord with the provisions of the Constitution relating to the appointment of the Chief Minister or Ministers of the Region or State. The term of the newly appointed Chief Minister or Ministers of the Region or State shall be the same as the remaining term of the President.
