## ANNOUNCEMENT ON PRINCIPLES OF NATIONAL RECONCILIATION AGREEMENT

PRESIDENT AND MEMBERS OF THE HOUSE OF REPRESENTATIVES PRESIDENT AND MEMBERS OF THE GENERAL NATIONAL CONGRESS UNITED NATIONS SECRETARY GENERAL

In the spirit of reconciliation and justice established by our Islamic faith, and in order to achieve national reconciliation within the framework of Security Council resolution no. (2009) dated December 16<sup>th</sup> 2011 that calls for supporting Libya in achieving peace, security, and the rule of law and according to resolution number (2174) calling for Libyan-Libyan dialogue under Libyan leadership;

And based on the resolution by the Presidency of the House of Representatives number (209) of 2015 regarding establishing a formal delegation under the leadership of the Head of the Justice and National Reconciliation Committee at the HOR and also the resolution of the Presidency of the General National Congress number (124) for the year 2015 regarding establishing a formal delegation under the leadership of the First Deputy of the President of the National Libyan Congress and the head of the dialogue team.

The goal of these principles is to establish true and viable cooperation between both the General National Congress and the House of Representatives in order to reach an agreement that lays the foundation for security and social tranquility in the state of Libya that is based on legislative balance and forming a Government of National Accord.

Therefore, both delegations have met without any foreign interference or any prior conditions and have agreed to present this draft national agreement to both the General National Congress and the House of Representatives to ratify it in a constitutional framework that brings about peace, tranquility, and establishes harmony and security for all under the rule of law and according to the following fundamental principles:

## First:

To resort back to the constitutional legitimacy of the previous Libyan constitution as it is considered to be the proper choice to resolve the problem of legislative powers in the country and to create the proper conditions in the country to carry out legislative elections within a maximum of two years.

## Second:

To form a committee of ten members five of which from the House of Representatives and a similar number from the General National Congress that would assist in selecting the Head of National Accord Government and two deputies. One of the deputies shall represent the General National Congress and the other shall represent the House of Representatives along with the President (Presidency of the Cabinet) in a period not to exceed two weeks.

## Third:

To form a committee of ten members five of which from the House of Representative and a similar number from the General National Congress that will be responsible for the emendation of the previously mentioned constitution and according to the needs and nature of the current phase.
