1.2. Socio-Economic Profile

Kirinyaga District:

- Is the fifth most densely populated district in the province;
- Has 87.4% primary school enrolment rate, ranking 3rd in the province and 6th nationally;
- Has 31.1% secondary enrolment rate, ranking 6th in the district and 14th nationally
- Experiences the following main diseases malaria, respiratory tract infections, skin diseases including ulcers, diarrhoea diseases, and intestinal worms;
- Has a child mortality rate of 36, ranking 7th nationally;
- Has a life expectancy of 63.5 ranking 8th nationally;
- 22.5% malnourishment rate of children under 5 years of age, being ranked 20th nationally.

Kirinyaga District has four parliamentary constituencies: namely Mwea, Gichugu, Ndia and Kerugoya/Kutus. These four constituencies cover a total area of 1,478 Km² and all the constituencies are represented by Members of Parliament (MP) from the Democratic Party (DP). Each of the MPs, on average, represent 114,276 constituents and a constituent area of 370Km².

2. CONSTITUENCY PROFILE

Mwea is composed of Tebere, Kangai, Mutithi, Murinduko, Miuu, Thiba, Nyangati, and Mt. Kenya Forest Divisions.

2.2. Socio-Economic Profile

The constituency is largely semi-arid and the least developed area of Kirinyaga District. The main economic activity is growing rice and horticultural products. The majority of the residents

are settlers from Ndia and Gichugu. The Mwea irrigation scheme was developed in the 1950's and the National Irrigation Board leased agricultural plots to growers.

2.3. **Electioneering and Political Information**

The constituency is largely a pro-opposition zone. After the inception of the multi-party politics, DP won both the 1992 and 1997 general elections. In 2002, the National Rainbow Coalition took the seat.

2.6. **Main Problems**

Main problems the constituency experiences are health, poor infrastructure, and ownership of the Mwea/Ngariama ranch, a thorny issue between the residents of Kirinyaga, Embu, and Mbeere.

3. **CONSTITUTION MAKING/REVIEW PROCESS**

3.1. **Constituency Constitutional Forums (CCFs)**

3.1.1. **Philosophy**

The Constituency Constitutional Forum (CCF) plays a very significant role in the review of the constitution. It is designated as one of the organs ‘through which the review process shall be conducted’ - (sec. 4(1) of the Constitution of Kenya Review Act, Cap.3A). The importance attached to the CCF arises from the recognition of the need to involve the people fully in the review of the constitution. Only through such participation of the public will the new constitution reflect the preferences, hopes and aspirations of the people. It would also increase people’s knowledge of constitutional issues, and facilitate their familiarity with the provisions of the new constitution. Additionally, the process, enhances the legitimacy of the constitution among Kenyans and their sense of ownership over it. In these ways the proper implementation and safeguarding of the constitution will be facilitated.

3.1.2. **Composition and Establishment**

The 1997 Review Act had provided for district forums ‘to mobilize communities at the local level for the purpose of civic education in preparation for the Commission’s work and to perform such other duties as the Commission may assign’ - (sec. 12A (6). The District Forums were to consist of members elected to represent locations, religious organizations, and the disabled, in addition to MPs and members of every local authority in the district. The Act contained several provisions prescribing minimum qualifications for membership and regulating the operations of the District Forums.

The Select Committee of the National Assembly, which reviewed the Act in early 2000, decided to replace the District Forums with Constituency Forums to get views ‘directly from the people in the constituency without necessarily going through the rigours of an election to determine the members of the forum’. It thought that this would provide for a more popular form of participation. It recommended on the simplification of the forum to avoid elections. The Select Committee envisaged the constituency forum as and ‘open forum with no specific structures’, which should be ‘flexible and easy to manage’. Its opinion was that the ‘existing leadership comprising Members of Parliament, councilors, community based organizations, religious groups and individuals should be able to present views and opinions directly from the grassroots’ (*The Report of the Parliamentary Select Committee Reviewing the Constitution of Kenya Review Act, 1997*, April 2000). It removed the regulatory powers of the Commission over the forum, its role being confined to the ‘facilitation’ of the forum. It also changed the function of the forum from the facilitation of civic education to also include facilitation and the collection of the views of the public on proposals to alter the constitution.

In view of the limited role of the CKRC in the establishment of the CCF's, the CKRC prepared and gazetted Guidelines for the operationalization of the constituency constitutional forums. The Guidelines stipulated that all the residents of a constituency would constitute the CCF. The CCF is described as one of the organs ' through which the review process shall be conducted' - (sec.4(1)). The CCF was thus one of the principal ways in which the views of the public were to be obtained.

In order to coordinate and facilitate the activities of the CCF, a Constituency Constitutional Committee (CCC) was to be established. The Guidelines proposed its membership to consist of 10 persons, of which three would be ex-officio: the local MP, the chair of the County Council in which the constituency is located, and the District Coordinator. The Guidelines stated that the membership would be as broad and representative of the people of the constituency as possible and recommended that at least a third of the committee should be women.

3.1.3. **Functions of CCF**

- Facilitation of collection of the views of the public at the constituency level on proposals to alter the constitution; and
- Debate and discussion of the views of the members of the public on proposals to alter the constitution.

In performance of these functions, the CKRC was required to visit all constituencies (Sec.18 (1)(a)).

3.1.4. **Functions of CCC**

- The functions of the CCC were mainly facilitative and advisory, the primary aim being to enhance the effective participation in the ownership of the constitution review process by the people at the constituency level;
- The CCC was also mandated to promote, facilitate and monitor civic education at the constituency level in collaboration with the District Coordinator and civic education providers;
- Additionally, the CCC had to ensure that the constituency had access to all information relevant to the review process in coordination with District Documentation centers; and
- Finally, the CCC was also mandated with the task of dissemination of the report of the CKRC. It was to be assisted in this by the District Coordinator, who was also its accounting officer, in relation to funds that were made available to it by CKRC.

It is important to emphasize that the Guidelines were advisory, and the local community was free to modify them to suit local circumstances. For example, the size of the CCC could be increased when and if adequate representation and diversity required it.

3.1.5. **Date of Commencement of Work**

The Constituency Constitutional Forum (CCF) was to run for an initial period commencing November 2001 up to September 2002. Accordingly, each Constituency Constitutional Committee (CCC) should have been constituted at the very latest by the end of November 2001. The Constituency Constitutional Forum was to be operational by that time.

3.2. **District Coordinators**

3.2.1. **Mandate/Terms of Reference**

- Be the local grass root representative;
- Perform the generalization activities in the district;
- Be in charge of the documentation center/s in the district, facilitate its/their respective management, ensuring they are stocked and are easily accessible to the public and also organize their safety and security;
- Gathering any relevant local information and materials for the purpose of constitution making;
- Facilitate the identification, classification and organization of the physical and electronic retrieval and dissemination of information and materials for constitution making;
- Supply such information needed by local constituency forums and committees;
- Liaise with other documentation centers nearby and others for information;
- In collaboration with constituency committees, identify and arrange venues for public hearing whenever the CKRC visits the constituencies in their area;
- Facilitate regular meetings of the constituency committees and involve local people as much as possible in discussing constitutional issues;
- Source and identify other key personnel that the CKRC may wish to consult or engage in its work;
- Identify and arrange for simultaneous local translations, sign language users, procurement and hiring of public address systems, transport and communication facilities for CKRC's meetings in the district;
- Monitor the implementation of civic education by civic education providers in the district;
- Facilitate the formation of constituency committees with guidance and assistance of CKRC; and
- Perform any other tasks as directed by CKRC.

3.2.2. **Criteria for Appointment**

- Diversity in the composition, taking into account ethnicity, age, religion and professional or occupational background; and
- Appointees had at least attained Kenya Certificate of Secondary Education or its equivalent.

4. **CIVIC EDUCATION**

Civic education in the constituency was carried out between 1st February 2002 and 24th April 2002

4.1. **Phases covered in Civic Education**

Phase 1: This stage preceded the collecting of views. It dealt with information, knowledge, skills and virtues, which enabled Kenyans to make informed choice and present their views to CKRC.

5.3. Concerns and Recommendations

The following are the recommendations made by the presenters in Mwea Constituency. The recommendations were collated around 43 areas of concern, from the Preamble to National integrity/identity. Only areas where recommendations were made in the constituency are covered. The numbers in parentheses represent the number of times the recommendation (bulleted) was made, either orally or through written memoranda. Each count on a specific recommendation was picked from an individual, a group or an organization. Where a presenter made different recommendations on the same area of concern, each recommendation was counted separately. Where no number appears in parentheses, the recommendation was made only once.

5.3.1. PREAMBLE

- The constitution should have a preamble (18)
- The preamble should capture the supremacy of the constitution itself.
- The preamble should state that Kenya is a God fearing country.
- The preamble should state our origin who we are, our purpose, our goals and show unity and prosperity of all Kenyans
- The preamble should state our nation vision of “ Kenyans desire to be united in their diversity and are committed to build a better Kenya for ourselves and prosperity
- The preamble should state that all Kenyans citizens are equal and be treated equally fro their good and glory of God
- The preamble should express the Sovereignty of all Kenyans.
- The preamble should state that Kenya shall always be a democratic state.

- The preamble should include a national vision of unity for Kenyans.
- The preamble should state Kenya's experience during the struggle for Independence. (6)

5.3.2. **DIRECTIVE PRINCIPLES OF STATE POLICY.**

- The constitution should provide that the law shall apply in a non-discriminatory manner to all Kenyans.
- The constitution should have statements capturing the national philosophy and guiding principles (7)
- The constitution should state that Kenya is a democratic state(
- The constitution should provide for the strict observation of the doctrine of separation of power by the government of the day.
- The constitution should provide guiding principles on national unity for Kenyans.
- The constitution should provide that important values that should be reflected in the constitution are life property asset and natural environment
- Love, peace unity, democracy, freedom, equality and social justice and progress are values to reflect in the constitutions constitution should provide that all these principles of the state should be enforceable (4)
- The constitution should provide for national symbols that are sacrosanct and should not be used by individuals or non-state institutions.

5.3.3. **CONSTITUTIONAL SUPREMACY.**

- The constitution should provide for its supremacy over all other laws in the country.
- Parliament should be a supreme body to amend some parts of the constitution by 65% majority votes as is the case now (5)
- The constitution should provide that this procedure should be replaced with 75% majority votes
- The constitution should be amended by a 90% majority votes
- The constitution should provide that the 56% majority votes should be raised to 93% majority votes
- The parliament power to amend the constitution should be limited (6)
- The constitution should provide that some parts of the constitution should be beyond the amending power of the constitution
- The constitution should provide that there should be some parts that is beyond the amending power of the constitution
- The constitution should provide that there should be public referendum when amending the constitution (22)

5.3.4. **CITIZENSHIP.**

- The constitution should confer to all persons born of Kenyan parents automatic citizenship. (15)
- The constitution should provide that Kenya citizenship can be acquired after living in Kenya for period of more that 10 years
- The constitution should provide that persons who have stayed in Kenya for more than five years should be considered fro citizenship
- The constitution should provide that Kenyan citizenship can be acquire by application through the relevant authorities
- The constitution should provide that citizenship can be acquires through application and registration
- The constitution should provide that spouses of Kenyan citizens regardless of gender should be entitled to automatic citizenship in Kenya (11)
- The constitution should provide that a child born of one Kenyan parent regardless of gender should be automatic citizen of Kenya (9)
- There should be the right to vote, to travel to any part of the country, to be protect natural resources an development conscience
- Citizens should have a right to good governance and should be sovereign
- THC constitution should provide that all Kenyans should be entitled to equal freedom and right which should be guaranteed in the constitution
- The constitution should provide that every citizen should have the right to vote, inheritance and acquire identification document
- The constitution should provide that a citizen of Kenya should have a right to easy issuance of passport
- The constitution should provide that rights and obligation should not depend on the manner in which citizenship is acquired
- The constitution should provide that every citizen irrespective of the manner in which citizenship is acquired should enjoy all the rights of a Kenyan citizen (3)
- The constitution should provide that the rights and obligation of a citizen should depend on the manner in which citizenship was acquired (2)
- The constitution should provide for dual citizenship.(7)
- the constitution should not provide for dual citizenship(2)
- The constitution should confer automatic citizenship to all persons legally married to a Kenyan citizen irrespective of gender.
- The constitution should provide that a non-Kenyan child adopted by a Kenyan citizen shall automatically qualify for Kenyan citizenship.
- the constitution should provide that Kenyans should carry ID cards as evidence of

documentation as Kenyans citizens

- Kenyans should carry ID, birth certificate, voters card, driving license or bank ATM machines as evidence of citizenship (7)
- The constitution should provide that Kenyans should carry identification documents that do not oppress them
- The constitution should provide that proof of citizenship shall be by way of National identification cards, birth certificates and passports.
- The constitution should confer automatic citizenship to all persons who have stayed in Kenya for a continuous period of more than five years.
- The constitution should provide that adopted children by a Kenyan citizen shall automatically qualify for Kenyan citizenship.
- The constitution should provide that proof of citizenship be ascertained through alternative documents such as birth certificate, driving license, passport or school leaving certificate.
- The constitution should provide that those born outside the country by parents one of who is a Kenyan should be granted automatic citizenship regardless of the gender of the parent.

5.3.5. **DEFENCE AND NATIONAL SECURITY.**

- The constitution should provide that no decisions affecting national policy on defense shall be made without the approval of parliament.
- The constitution should establish a disciplined force (17)
- The undisciplined force should be sent to the military disciplinary council for interrogation, sacked then prosecuted in an ordinary court of law
- The constitution should provide that tribunal to discipline the force should be entrenched
- The constitution should provide that the armed force should be disciplined through special courts
- There should be a defense commission under parliament which should be responsible for disciplining the force
- The disciplined force should be disciplined through court martial
- The disciplined force should be disciplined through code of ethics
- The president should be the commander in chief of the armed forces (11)
- The constitution should provide that the president shall not be the Commander in Chief of the armed forces. This role should instead be transferred to an appointee of parliament.

- The constitution should provide for an end to police torture.
- The constitution should put up mechanisms to curb corruption in the police force.

5.3.6. **POLITICAL PARTIES.**

- The constitution should limit the number of political parties in the country.
- The constitution should provide that political parties should have a role in development (8)
- The constitution should regulate the formation, management and conduct of political parties (14)
- The constitution should limit the number of political parties in the country to 3 and they should be funded by the state on the strength of the number of seats they hold in parliament.
- The constitution should limit the number of political parties in the country to 2(5)
- The constitution should provide for three political parties (13)
- The constitution should provide for 10 political parties
- The constitution should make provision for five political parties
- The political parties should be financed by the members (20)
- The political parties should be financed by the government
- The political parties should be funded through parliament and national budget)
- All political parties should be financed from the public funds in the proportion of 60% to the ruling party and the remainder to the other parties each 20%
- The constitution should provide the official opposition parties should be funded by the state

- The constitution should provide that there shall be no limit in the number of political parties.
- The constitution should provide for public funding of all political parties participating in a given general election.
- The constitution should provide that no political party shall be registered unless it has 500 registered members and nobody should be allowed to belong to more than one political party.
- The constitution should provide that the state shall not fund any political party and likewise desist from interfering with the functions of the said parties.
- The constitution should provide that ethnic groups be recognized as an avenue for political representation as opposed to political parties.
- The constitution should provide that political parties that have at least 10% of votes in 4 provinces in elections be funded by the state.
- The constitution should provide that political parties nominate their parliamentary candidates on the same day.
- The constitution should provide that the state shall fund the three largest political parties.
- The constitution should provide that political parties shall only merge after a referendum involving members of the concerned parties.

5.3.7. **STRUCTURES AND SYSTEMS OF GOVERNMENT.**

- The constitution should provide for a parliamentary system of government with a prime minister as the head of government.
- The constitution should provide that if the president is a man, the Vice president should be a woman and vice versa.
- The constitution should retain the presidential system of government (5)
- The constitution should not retain the presidential system of government (2)
- The constitution should provide for the post of a prime minister
- The constitution should provide for a ceremonial president
- The prime minister should be the head of the government (11)
- The president should be the head of the state (8)
- The constitution should adopt a hybrid system of government
- The constitution should provide that the attorney general should be appointed by a special committee of parliament
- The constitution should provide that the Attorney General shall not have the power to terminate corruption cases involving public funds.
- The constitution should provide for an independent electoral commission, which should have members drawn from NGOs and COTU.
- The constitution should provide for the direct election of the vice-president as the running mate of the president.
- The constitution should provide that the president shall have a running mate who will automatically become a vice-president upon his election.
- The constitution should provide for a ceremonial president elected for a one five year term by parliament and an executive prime minister who should be an elected MP and a university graduate.
- The constitution should provide that the Vice President be directly elected by popular vote as the President's running mate.
- The constitution should provide for a parliamentary system of government
- The constitution should provide for a parliamentary system of government in which the National Assembly chooses the Prime Minister.
- The constitution should provide for a Unitary system of government.(9)
- The constitution should adopt a federal system of government (3)
- The constitution should not adopt a federal system of government
- The constitution should provide that power should be devolved to the lower levels of government
- The constitution should provide that the vice president should be elected directly by the people (4)
- The constitution should provide that the attorney general should be appointed by parliament
- The constitution should provide the attorney general should be appointed by a commission set by parliament
- The constitution should provide that the attorney general should appointed and vetted by parliament
- The constitution should provide for a unitary system of government with a ceremonial President who shall serve for a two five year term and an executive Prime Minister elected by the people.
