INTRODUCTION

The legal and Constitutional Commission set up in accordance with the Arusha Peace Agreement and the law n° 23/99 dated 24/12/1999 provides for the following in Article 2:

"The Commission for preparing the Constitution and revising other laws" has the mission to:

- Prepare the draft-bill of the Constitution;
- Search for, receive and collect thoughts given by the population and to make use of examples from others countries;
- Explain to the population what the Constitution is and the main ideas which it is comprised of;
- Prepare the draft-bills of laws that govern the last transition period;
- Put together all the laws which must be modified in order to adapt them to the Constitution.

Within this regard, the Commission has elaborated a Strategic Action Plan taking over a three-year period, which has been divided in six phases, to reflect its legislative mission.

They are:

- The training and sensitisation of the population about the Constitution;
- The consultation of the population on the content of the Constitution;
- The writing and validation of the draft text of the Constitution;
- The referendum on the text of the Constitution as approved by Parliament;
- The management of the last period of the Transition;
- The harmonisation between the laws and the new Constitution.

A continuous review of the Strategic Action Plan has taken place and has updated all along its execution, with regard to both activities and costs. Due to budget provided by the Government and various donors some activities have been realised and others are taking place today.

Those activities are:

- The training of Commissioners and the Staff;
- Analysis on elaborating a Constitution;
- Techniques of elaborating a Constitution and laws;
- Computer skills;
- The elaboration of the population training material about the Constitution and training of leaders;
- The sensitisation of the population on the work of the Commission and on the Constitution making process;
- The acquisition of basic material and knowledge;
- The consultation of the population on the content of the Constitution;
- The recruiting of staff and the administration of the Commission.

To meet its mission objectives the Commission priories an approach that is inclusive and that favours participation of all categories of the population in the process of elaborating the new Constitution.

To carry its mandate and to live within its limited budget, the Commission has given priority to the following activities:

- The sensitization the population through media outreach and through the voice of trained local leaders in districts and in specialized groups;
- The consultation of the population through meetings with Commissioners in districts and with specialized group at the local and national level;
- The validating of the Constitution's main themes with local leaders and the writing of the draft of the Constitution;
- The holding a nation wide referendum on the proposed text of the Constitution;
- The elaboration of laws governing the last period of the Transition and the harmonization of other laws with the new Constitution.

As we submit this plan of action, the training and sensitization activities that had been planned have taken place and we can report that they met all of our expectations. Rwandans have clear understanding of the Constitutional making process and can relate to the work of the Commission.

The consultation phase of our activities has been underway since February. We are half way into the process. Commissioners have been assigned to areas of the country and are holding consultation meetings daily. Participation is high and feedback is extremely positive. Rwandans share their views and their aspirations with interest and enthusiasm.

A plan of action is a work in progress. As we move toward the date of the referendum, the Commission intends to continue to update its plan as to make it the instrument of success of this great national project.

THE TRAINING AND SENSITIZING OF RWANDANS ABOUT THE CONSTITUTION.

1. INTRODUCTION

The action of teaching and explaining to different categories of the population what a constitution is and its main ideas is the mission of the Commission in charge of elaborating the constitution and reviewing other laws.

This program is aimed at teaching and explaining to the Rwandans in their respective places, either in the country or abroad, what a constitution is, showing them its main concepts, its importance and preparing them to give their views which will help in drafting the constitution that will govern the country after the transition period.

For Rwandans who live in foreign countries, means of international communication (internet, fax, post...) and reaching them in their countries of residence will be used. The members of the commission will reach those who live in refugee camps in Tanzania, Zambia, Uganda, Congo Brazzaville and others, if possible.

This program was intended for Rwandans living in the country and was divided into two phases in order to allow each Rwandan to have time to be taught, trained and then discuss with members of the Commission about the constitution making process.

The first training was carried out by the members of the commission and was intended for specialized groups. The second training was intended for the population, was carried out by local leaders under the supervision of the commissioners.

2. PROGRAM FOR TRAINING.

PART ONE: Program for training the population trainers

Due to the fact that the commissioners could not reach and teach every Rwandan, they found it necessary to collaborate with the local levels of administration headed on the national level by the Ministry of Local Government and Social Affairs.

This training was held on two levels: the national level and provincial level.

1. On the national level

On this level, the Commission trained forty (40) people who had sufficient knowledge about the constitution so that they could help the members of the Commission in the training of the representatives at district, town and sector levels.

This group comprises twelve (12) commissioners, four (4) employees from the Ministry of Local Government and Social Affairs and two (2) from each province and Kigali city, one person in charge of Legal and Administrative Affairs, one in charge of good governance; and 12 representatives of women from provincial level. This training took place from 10 to 13 July 2001.

The fact that the commissioners were trained at the same time as other was prompted by the idea that the whole group must have the same angle of vision about the process of teaching the population since it is the same group which is going to coordinate all activities.

2. On provincial level

On the level of all provinces of the country, the commissioners in collaboration with the trained persons in each province have trained within one day nine thousand and eight hundred (9800) representatives. Among others, there are:

- Members of the executive committees of all districts and towns
 (5 members of the executive committees x 106 districts and towns: 530 persons)
- Members of Political and Administrative Committee in all sectors. This committee is composed of the coordinator of the sector, secretary of the committee, one in charge of security and one in change of information. (4 persons x 1545 sectors = 6180 persons)
- One person in charge of education and training in the Community and Development Committee on the level of each sector, and the counsellor elected in each sector.
 - (2 persons x 1545 sectors = 3090 persons).

The training of this group took place from July to September 2001.

The provinces were divided into zones in accordance to the maximum number of persons who could be trained at once.

Before ending the training, the commissioners assisted the trainers in elaborating the program of training the population.

PART TWO: Program of training specialized groups.

The specialized groups that participated in the training were divided into three categories: the national level, the provincial level, and the district and town level.

Here is a list of some of these groups:

1. On the national level

- Ministers and Secretary Generals of the Ministries
- Employees of the central Governance
- The parliamentarians
- Members of the Supreme Court
- Directors of public institutions (OCIR, BRD, RWANDATEL, ELECTROGAZ, ORINFOR, FARG...)
- Rwandan citizens who work for the international community:
 - In embassies
 - In international organizations
 - In UNO agencies
- Lecturers and students of universities and higher institutions: UNR, ULK, KIST, KIE, ISFP, KHI, ISAE and the Adventist Universities.

- Members of the executive committees of legalized political parties
- Those in charge of the national security (in army and police)
- Employees of international and Rwandan non Government organizations
- Government and private journalists
- Self employed and private sectors
- Religious leaders in Rwanda.

These training sessions took place in September 2001.

2. On provincial level.

- Those in charge of security (in army and police)
- Province employees
- Province civil servants
- Employees of international organizations and Rwandans of non-government organizations.
- The representatives of projects operating in the province
- Teachers and students of public and private secondary schools.
- Associations and religious leaders
- Employees of the prisons
- Prisoners.

These sessions were held between July and the September 2001.

3. On district and town level.

- District and town employees
- In charge of security (in army and police)
- Priests and employees of the parishes
- Teachers of primary and secondary schools
- Associations and cooperatives members
- Employees of international and Rwandan non government organizations
- Civil servants working in the district or town.

These took take place at the same time as the sessions at the provincial level.

3. PROGRAM OF SENSITISATION

The sensitisation program kicked off immediately after the training of local leaders, in August and September 2001, who in turn went down to sensitise the local population. Sensitisation sessions took place at secteur and cellule level. With the assistance of the training manual the local leaders educated the local population.

The main objective of the sensitization phase was to explain to the population, what the Constitution is, its importance and the main elements that make up a Constitution as well to mobilize them for their later participation in the Constitution making process, which would bring an end to the transition government. The sensitization activities were the same across the country. The agenda was as follows:

- Introduction to the purpose of the meeting
- Information on the mandate of the Commission
- Basic Information on the Constitution
- Instruments of power in Government
- Nature of political systems
- Human rights and the role of citizens

- Past Constitutions of Rwanda
- Genocide and its effects
- Questions and recommendations
- Conclusion.

Turn up for most of the sessions was good with an average of 90.000 people at each province that includes secondary school students and prisoners.

In its July to December 2001, semi-annual report, the Commission reported at length on the outcome of the training and sensitising activities. This report is public.
