- 4. FINALISATION OF DRAFT CONSTITUTIONAL PROVISIONS FOR BLOCK 8 (FOREIGN RELATIONS AND INTERNATIONAL LAW)
- 4.1 Dr Heunis tabled the Draft Constitutional Provisions for Block 8 dealing with Foreign Relations and International Law [Document A35 Extra Documentation]. He reported that these Draft Provisions had been prepared with reference to the draft prepared by Prof John Dugard and in consultation with him and the Law Advisors of the Department of Foreign Affairs as well as with reference to the submissions made to the Theme Committee on this issue.
- 4.2 After discussion of the draft constitutional provisions by the Theme Committee, it was agreed that the following amendments should be made to the document:
 - 4.2.1 Page 4, Paragraph (10) should be amended in order to clarify that in the case where there may be a conflict between an Act of Parliament and customary international law, the Act of Parliament would prevail.
 - 4.2.2 It was agreed that the ANC's contentious proposal in the Report for Block 8 regarding the declaration of a state of national defence be given expression in the form of draft provisions. It was agreed that the Technical Experts should amend the Draft Constitutional Provisions to include this proposal.
- 4.3 It was further agreed that, subject to the agreed amendments being made to the Draft Constitutional Provisions, the Report on Block 8 was approved for submission to the CC and that the revised draft would be circulated to Theme Committee members.
