1. OPENING

4. REPORT FROM CHAIRPERSONS MEETING

The Chairperson read through the Memo from the Chairpersons Meeting held on Thursday, 16 February 1995.

5. DISCUSSION ON GUIDELINES FOR THEME COMMITTEE REPORTS

The meeting agreed that this matter would be discussed at the Core Group meeting together with the Secretariat and if necessary with the CA chairpersons.

6. REPORT FROM TECHNICAL EXPERTS ON SUPPLEMENTARY REPORT OF PUBLIC SUBMISSIONS

The technical experts, Professor Corder and Mr. Husain presented the following two reports to the Theme Committee, viz.:
