1. DISTRICT CONTEXT

Migori Constituency is a constituency in Migori District. Migori District is one of 12 districts of the Nyanza Province of Kenya.

1.2 Socio-Economic Profile

Migori District:

- Is one of the least densely populated districts in the province, being ranked 8th of the 12 districts;
- Has one of the highest primary school enrolment rates in the province, at 76.1%, being ranked 4th in the province and 24 nationally;
- Has one of the least secondary school enrolment rates in the province at 15.4%, being ranked 9th in the province and 43rd nationally;
- Experiences the following main diseases: diarrhoea diseases, Malaria, sexually transmitted infections, intestinal worms, and typhoid;
- Has a 14.5% malnourishment rate of children under 5 years of age, being ranked 4th of 42 of the nationally ranked districts;
- Has a life expectancy of 45.7 years being ranked 41 of the 45 nationally ranked districts;
- Has an absolute poverty level of 57.63% being ranked 29th of 46 nationally ranked districts;
- Has a 41.12% food poverty level being ranked 15th of 42 nationally ranked districts;
- Has a monthly mean income of Ksh.3,909;
- Has a 11.36% unemployment rate;
- Has 18.60% of its residents accessing clean drinking water; and
- 41.40% of its residents having safe sanitation.

Migori district has 4 constituencies: Rongo, Migori, Uriri, and Nyatike Constituencies. The district's 4 MPs, each cover on average an area of 501 Km² to reach 128,724 constituents. This is an opposition stronghold. In the 1997 general elections, NDP won all the parliamentary seats. It won Rongo, Migori, Uriri, and Nyatike constituencies with 66.67%, 64.10%, 77.86%, and 71.88% valid votes respectively.

2. **CONSTITUENCY PROFILE**

The Suba speaking Suna clan, and the largely cosmopolitan Migori Town, dominate Migori Constituency. The large Kanyamkago clan was hived off Migori to form Uriri Constituency. Migori Constituency is comprised of Suna Central, Suna East, Suna South, Suna West, Lower Suna and upper Suna.locationsof Suba divisions of Migori District.

2.2. Electioneering and Political Information

This is an opposition stronghold. In the 1992 and 1997 general elections, FORD-K and NDP won the parliamentary seats with 88.41% and 82.64% valid votes. A by-election was conducted in 1993 after the defection of the elected 1992 MP from FORD-K to KANU: FORD-K won the election with 82.64 valid votes. In 2002, the National Rainbow Coalition won the seat.

3. CONSTITUTION MAKING/REVIEW PROCESS

3.1. Constituency Constitutional Forums (CCFs)

3.1.1. Philosophy

The Constitution Constitutional Forum (CCF) plays a very significant role in the review of the constitution. It is designated as one of the organs 'through which the review process shall be conducted' - (sec. 4(1) of the Constitution of Kenya Review Act, Cap.3A). The importance attached to the CCF arises from the recognition of the need to involve the people fully in the review of the constitution. Only through such participation of the public will the new constitution reflect the preferences, hopes and aspirations of the people. It would also increase people's knowledge of constitutional issues, and facilitate their familiarity with the provisions of the new constitution. Additionally, the process, enhances the legitimacy of the constitution among Kenyans and their sense of ownership over it. In these ways the proper implementation and safeguarding of the constitution will be facilitated.

3.1.2. Composition and Establishment

The 1997 Review Act had provided for district forums 'to mobilize communities at the local level for the purpose of civic education in preparation for the Commission's work and to perform such other duties as the Commission may assign' - (sec. 12A (6). The District Forums were to consist of members elected to represent locations, religious organizations, and the disabled, in addition to MPs and members of every local authority in the district. The Act contained several provisions prescribing minimum qualifications for membership and regulating the operations of the District Forums.

The Select Committee of the National Assembly, which reviewed the Act in early 2000, decided to replace the District Forums with Constituency Forums to get views 'directly from the people in the constituency without necessarily going through the rigors of an election to determine the members of the forum'. It thought that this would provide for a more popular form of participation. It recommended on the simplification of the forum to avoid elections. The Select Committee envisaged the constituency forum as and 'open forum with no specific structures', which should be 'flexible and easy to manage'. Its opinion was that the 'existing leadership comprising Members of Parliament, councilors, community based organizations, religious groups and individuals should be able to present views and opinions directly from the grassroots' (The Report of the Parliamentary Select Committee Reviewing the Constitution of Kenya Review Act, 1997, April 2000). It removed the regulatory powers of the Commission over the forum, its role being confined to the 'facilitation' of the forum. It also changed the function of the forum from the facilitation of civic education to also include facilitation and the collection of the views of the public on proposals to alter the constitution.

In view of the limited role of the CKRC in the establishment of the CCF's, the CKRC prepared and gazetted Guidelines for the operationalization of the constituency constitutional forums. The Guidelines stipulated that all the residents of a constituency would constitute the CCF. The CCF is described as one of the organs 'through which the review process shall be conducted' - (sec.4(1)). The CCF was thus one of the principal ways in which the views of the public were to be obtained.

In order to coordinate and facilitate the activities of the CCF, a Constituency Constitutional Committee (CCC) was to be established. The Guidelines proposed its membership to consist of 10 persons, of which three would be ex-officio: the local MP, the chair of the County Council in which the constituency is located, and the District Coordinator. The Guidelines stated that the membership would be as broad and representative of the people of the constituency as possible and recommended that at least a third of the committee should be women.

3.1.3. Functions of CCF

- Facilitation of collection of the views of the public at the constituency level on proposals to alter the constitution; and
- Debate and discussion of the views of the members of the public on proposals to alter the constitution.

In performance of these functions, the CKRC was required to visit all constituencies (Sec.18 (1)(a)).

3.1.4. Functions of CCC

- The functions of the CCC were mainly facilitative and advisory, the primary aim being to enhance the effective participation in the ownership of the constitution review process by the people at the constituency level;
- The CCC was also mandated to promote, facilitate and monitor civic education at the constituency level in collaboration with the District Coordinator and civic education providers;
- Additionally, the CCC had to ensure that the constituency had access to all information relevant to the review process in coordination with District Documentation centers; and
- Finally, the CCC was also mandated with the task of dissemination of the report of the CKRC. It was to be assisted in this by the District Coordinator, who was also its accounting officer, in relation to funds that were made available to it by CKRC.

It is important to emphasize that the Guidelines were advisory, and the local community was free to modify them to suit local circumstances. For example, the size of the CCC could be increased when and if adequate representation and diversity required it.

3.1.5. Date of Commencement of Work

The Constituency Constitutional Forum (CCF) was to run for an initial period commencing November 2001 up to September 2002. Accordingly, each Constituency Constitutional Committee (CCC) should have been constituted at the very latest by the end of November 2001. The Constituency Constitutional Forum was to be operational by that time.

3.2. **District Coordinators**

3.2.1. Mandate/Terms of Reference

- Be the local grass root representative;
- Perform the generalization activities in the district;
- Be in charge of the documentation center/s in the district, facilitate its/their respective management, ensuring they are stocked and are easily accessible to the public and also organize their safety and security;
- Gathering any relevant local information and materials for the purpose of constitution making;
- Facilitate the identification, classification and organization of the physical and electronic retrieval and dissemination of information and materials for constitution making;
- Supply such information needed by local constituency forums and committees;
- Liaise with other documentation centers nearby and others for information;
- In collaboration with constituency committees, identify and arrange venues for public hearing whenever the CKRC visits the constituencies in their area;
- Facilitate regular meetings of the constituency committees and involve local people as much as possible in discussing constitutional issues;
- Source and identify other key personnel that the CKRC may wish to consult or engage in its work;
- Identify and arrange for simultaneous local translations, sign language users, procurement and hiring of public address systems, transport and communication facilities for CKRC's meetings in the district;

- Monitor the implementation of civic education by civic education providers in the district;
- Facilitate the formation of constituency committees with guidance and assistance of CKRC;
 and
- Perform any other tasks as directed by CKRC.

3.2.2. Criteria for Appointment

- Diversity in the composition, taking into account ethnicity, age, religion and professional or occupational background; and
- Appointees had at least attained Kenya Certificate of Secondary Education or its equivalent.

4.3. Concerns and Recommendations

The following are the recommendations made by the presenters in Migori Constituency. The recommendations were collated around 43 areas of concern, from the Preamble to National integrity/identity. Only areas where recommendations were made in the constituency are covered. The numbers in parentheses represent the number of times the recommendation (bulleted) was made, either orally or through written memoranda. Each count on a specific recommendation was picked from an individual, a group or an organization. Where a presenter made different recommendations on the same area of concern, each recommendation was counted separately. Where no number appears in parentheses, the recommendation was made only once.

4.3.1. PREAMBLE

- The constitution should have a preamble (13).
- The preamble should set out a national vision (8).
- The preamble should state that Kenya is a sovereign state and in god we trust.
- The preamble should state that Kenya is made up of different tribes and people of different cultural backgrounds.
- The preamble should reflect the common experiences of Kenyans such as the struggle for independence (2).
- The preamble should reflect national unity.
- The constitution should have a preamble addressing the social and cultural aspects of Kenya

4.3.2. **DIRECTIVE PRINCIPLES OF STATE POLICY.**

- The constitution should provide that there is need for statements capturing national philosophy and guiding principles (6).
- The constitution should provide that democratic principles shall be included in the constitution (3).
- The constitution shall be people driven.
- The constitution should define, recognize and honour the people of Kenya to enable them know the constitution.
- The constitution shall be supreme (2).
- The constitution shall be for the people, of the people and written by the people.
- The constitution should provide for separation of powers between executive and other arms of government.
- The constitution should provide that unity, peace, love and liberty are some values that shall be reflected in the constitution (2).
- The constitution should provide that there shall be values reflected in the constitution (3).
- The constitution should provide that national unity, justice and happiness shall be values to be reflected in the constitution.
- The constitution should provide that these principles shall be enforceable in law (3).

4.3.3. **CONSTITUTIONAL SUPREMACY.**

- The constitution should provide that any amendment to the constitution requires a 2/3 majority vote in parliament
- The constitution should retain the 65% majority vote for any amendments of the constitution (4).
- The constitution should provide that the 65% majority vote required shall be increased to 75% (2).
- The constitution should retain the 65% majority vote for any amendments but it shall be subject to the ascent of the president on advise of the prime minister.
- The constitution should provide that parliament shall be the noble organ to amend the constitution.
- The constitution should provide that parliament's power to amend the constitution shall be limited.
- The constitution should provide that the constitution shall definitely have parts which are beyond its amending power.
- The constitution should provide that a constitutional amendment should only be through a public referendum (9).
- The constitution should provide that the public referendum shall be conducted by an independent constitutional commission.
- The constitution should provide that the public referendum shall be conducted by the judiciary.
- The constitution should be reviewed after 10 years
- The constitution should be supreme over all other laws on the land

4.3.4. **CITIZENSHIP.**

• The constitution should provide that all persons born in Kenya should acquire automatic

- citizenship (6).
- The constitution should provide that all children born of Kenyan parents regardless of the parent's residence should be entitled to automatic citizenship.
- The constitution should provide that indigenous Kenyans shall acquire automatic citizenship.
- The constitution should provide that Kenyan citizenship shall be acquired by adoption and assimilation.
- The constitution should provide that Kenyan citizenship shall be acquired by taking solemn oath of loyalty and allegiance to Kenya.
- The constitution should provide that Kenyan citizenship shall be acquired by registration, naturalization and assimilation.

- The constitution should provide that every Kenyan shall be obligated to the spirit of nationhood and protect the image of the country abroad.
- The constitution should provide that the rights and obligations of a citizen shall depend on the manner in which the citizenship is acquired.
- The constitution should provide that the rights and obligations of a citizen shall NOT depend on the manner in which the citizenship is acquired.
- The constitution should allow for dual citizenship.
- The constitution should NOT allow for dual citizenship (2).
- The constitution should provide that National ID and passport shall be issued free of charge and used as proof of citizenship.
- The constitution should provide that all citizens above 18 years shall be issued with ID cards and passports automatically.
- The constitution should provide that ID's for married people shall bear the names of both husband and wife.
- The constitution should provide that every Kenyan shall be issued with a National ID card with details of NSSF numbers, a passport and a driving license with simplified procedures and all of them be used as proof of citizenship.
- The constitution should provide that national ID shall be used as proof of citizenship (2).
- The constitution should provide that ID's and passport shall be used as proof of citizenship (3).

- The constitution should provide that ID's and voters card shall be used as proof of citizenship.
- The constitution should provide that foreign women married to Kenyans shall be given ID's.
- The constitution should provide that passports shall be issued on request.
- The constitution should provide that passports and ID be easily availed (2).
- The constitution should provide for the issuance of passports alongside ID (3)
- The constitution should make ID cards free (2)

4.3.5. **DEFENCE AND NATIONAL SECURITY.**

- The constitution should compel the armed forces to station at least one determent station at strategic positions with each province especially those bordering neighboring countries.
- The constitution should improve on the recruitment process so that recruits are vetted by the local community through the chief to ascertain that they are people of good characters and shall be issued with a certificate of good conduct.
- The constitution should provide that Administration Police shall have limited jurisdiction to the particular state operations.
- The constitution should provide that military and paramilitary police prisons shall be established and their duties and jurisdiction shall be specified.
- The constitution should provide that the regular police and provincial administration police shall be merged to the unit.
- The constitution should provide that military, paramilitary, police, prisons and national youth service shall be established and their duties and obligations shall be clearly defined.
- The constitution should provide that disciplined forces shall be established in the constitution and GSU established.
- The constitution should provide that all the armed forces shall be under the inspector general.
- The constitution should provide that disciplined forces shall be established in the constitution (4).
- The constitution should provide that the disciplined forces shall be subjected to parliamentary act.
- The constitution should provide that the disciplined forces, the police, shall be established both at the regional level and the central government level.
- The constitution should provide a commissioner general to be in charge of police
- The constitution should reduce the powers of the police
- The constitution should provide for training of vigilantes
- The constitution should criminalize corruption in the police
- The constitution should provide for the establishment of a body to oversee the police
- The constitution should provide that police force shall be independent.
- The constitution should provide that police force shall be transferred after every three months.
- The constitution should provide that the police force shall be politically neutral and professionals to guarantee internal security of the country.
- The constitution should provide that the armed forces shall be disciplined by the current system of military police and court martial.
- The constitution should provide that administration police shall be trained for two years in matters pertaining to law, psychology and human management.

- The constitution should provide that members of disciplined forces shall be disciplined by court martials.
- The constitution should provide that all disciplined forces shall be tried in the militia courts.
- The constitution should provide that the police officers shall not be allowed to stay in one station for many years.
- The constitution should provide that the president shall be the commander in chief of the armed forces (7).
- The constitution should provide that the executive shall have exclusive power to declare war.
- The constitution should provide that the executive shall NOT have exclusive power to declare war (2).
- The constitution should provide that parliament shall have exclusive power to declare war (2).
- The constitution should provide that the executive shall NOT have exclusive power to declare war except through the advise of a military advisory commission that shall include the chief of the defense staff, the army, air force, navy and minister of foreign affairs among others.
- The constitution should permit the use of extra-ordinary powers in emergencies (4).
- The constitution should provide that the president on the advise of the prime minister shall have the authority to invoke emergency powers.
- The constitution should provide that parliament shall have the authority to invoke emergency powers.
- The constitution should provide that the president shall have the authority to invoke emergency powers.
- The constitution should provide that the citizens shall present their views to parliamentary committee before parliament debates and decides on the merits of extra-ordinary power applicability.
- The constitution should provide that parliament shall have a role in effecting continuation of state of emergency after a period of six months expires and a further of every three months.
- The constitution should provide that parliament shall veto legislation before invoking emergency powers.

4.3.6. **POLITICAL PARTIES.**

- The constitution should provide that political parties shall have other roles apart from political mobilization such as civic education, initiate development agents and implement them as per part manifesto.
- The constitution should provide that political parties shall have a role in management of affairs.
- The constitution should provide broad guidelines for the formation, management and conduct of political parties (7).
- The constitution should limit the number of political parties in the country to 2 (3)
- The constitution should limit political parties to 4 (2).
- The constitution should not limit the number of political parties.
- The constitution should limit the number of political parties to 3 (4).
- The constitution should limit the number of political parties to 5 (5).

- The constitution should provide for funding of political parties by the government from public coffers (9).
- The constitution should provide that the state shall NOT fund political parties.

- The constitution should provide for a provincial assembly with senators
- The constitution should not allow for a military government.

Physical, Economic and Social Infrastructure
