1.2 Socio-Economic Profile

Machakos District:

- Is the 5th most densely populated district in the province;
- Has a 85.9% primary school enrolment rate, being the leading in the province and ranking 10th nationally;
- Has a 28.0% secondary school enrolment rate, being ranked 4th in the province and 18th nationally;
- Experiences the following main diseases: Malaria, upper respiratory tract infections, skin diseases and infections, diarrhea diseases, and urinary tract infections;
- Has a child mortality rate of 45%, being ranked 11th nationally;
- Has a life expectancy of 68.1 years, being ranked 2nd nationally;
- Has a 27.0% malnourishment rate of children under 5 years of age, being ranked 29th nationally; and
- Has a population of 63% that is considered among the absolute poor.

Machakos district has 6 constituencies: Masinga, Yatta, Kangundo, Kathiani, Machakos Town, and Mwala. The district's 6 MPs each cover on average an area of 1047 Km² to reach 151,107 constituents.

2.6 Main Problems

Clean water is a major problem. Poor and inefficient road network affects transport systems in the area. Famine is frequent and the government has done little to alleviate their socio economic problems. On the other hand Mwala constituents feel that the government has been using food as a campaign tool by giving out handouts to the starving just when general elections are around the corner. Poor roads make it difficult to access medical services that are also scattered and under stocked with medicine.

3. CONSTITUTION MAKING/REVIEW PROCESS

3.1. Constituency Constitutional Forums (CCFs)

3.1.1. Philosophy

The Constituency Constitutional Forum (CCF) plays a very significant role in the review of the constitution. It is designated as one of the organs ‘through which the review process shall be conducted’ - (sec. 4(1) of the Constitution of Kenya Review Act, Cap.3A). The importance attached to the CCF arises from the recognition of the need to involve the people fully in the review of the constitution. Only through such participation of the public will the new constitution reflect the preferences, hopes and aspirations of the people. It would also increase people’s knowledge of constitutional issues, and facilitate their familiarity with the provisions of the new constitution. Additionally, the process, enhances the legitimacy of the constitution among Kenyans and their sense of ownership over it. In these ways the proper implementation and safeguarding of the constitution will be facilitated.

3.1.2. Composition and Establishment

The 1997 Review Act had provided for district forums ‘to mobilize communities at the local level for the purpose of civic education in preparation for the Commission’s work and to perform such other duties as the Commission may assign’ - (sec. 12A (6). The District Forums were to consist of members elected to represent locations, religious organizations, and the disabled, in addition to MPs and members of every local authority in the district. The Act contained several provisions prescribing minimum qualifications for membership and regulating the operations of the District Forums.

The Select Committee of the National Assembly, which reviewed the Act in early 2000, decided to replace the District Forums with Constituency Forums to get views ‘directly from the people in the constituency without necessarily going through the rigours of an election to determine the members of the forum’. It thought that this would provide for a more popular form of participation. It recommended on the simplification of the forum to avoid elections. The Select Committee envisaged the constituency forum as an ‘open forum with no specific structures’, which should be ‘flexible and easy to manage’. Its opinion was that the ‘existing leadership comprising Members of Parliament, councilors, community based organizations, religious groups and individuals should be able to present views and opinions directly from the grassroots’ (*The Report of the Parliamentary Select Committee Reviewing the Constitution of Kenya Review Act, 1997*, April 2000). It removed the regulatory powers of the Commission over the forum, its role being confined to the ‘facilitation’ of the forum. It also changed the function of the forum

from the facilitation of civic education to also include facilitation and the collection of the views of the public on proposals to alter the constitution.

In view of the limited role of the CKRC in the establishment of the CCF's, the CKRC prepared and gazetted Guidelines for the operationalization of the constituency constitutional forums. The Guidelines stipulated that all the residents of a constituency would constitute the CCF. The CCF is described as one of the organs ' through which the review process shall be conducted' - (sec.4(1)). The CCF was thus one of the principal ways in which the views of the public were to be obtained.

In order to coordinate and facilitate the activities of the CCF, a Constituency Constitutional Committee (CCC) was to be established. The Guidelines proposed its membership to consist of 10 persons, of which three would be ex-officio: the local MP, the chair of the County Council in which the constituency is located, and the District Coordinator. The Guidelines stated that the membership would be as broad and representative of the people of the constituency as possible and recommended that at least a third of the committee should be women.

3.1.3. **Functions of CCF**

- Facilitation of collection of the views of the public at the constituency level on proposals to alter the constitution; and
- Debate and discussion of the views of the members of the public on proposals to alter the constitution.

In performance of these functions, the CKRC was required to visit all constituencies (Sec.18 (1)(a)).

3.1.4. **Functions of CCC**

- The functions of the CCC were mainly facilitative and advisory, the primary aim being to enhance the effective participation in the ownership of the constitution review process by the people at the constituency level;
- The CCC was also mandated to promote, facilitate and monitor civic education at the constituency level in collaboration with the District Coordinator and civic education providers;
- Additionally, the CCC had to ensure that the constituency had access to all information relevant to the review process in coordination with District Documentation centers; and
- Finally, the CCC was also mandated with the task of dissemination of the report of the CKRC. It was to be assisted in this by the District Coordinator, who was also its accounting officer, in relation to funds that were made available to it by CKRC.

It is important to emphasize that the Guidelines were advisory, and the local community was free to modify them to suit local circumstances. For example, the size of the CCC could be increased when and if adequate representation and diversity required it.

3.1.5. **Date of Commencement of Work**

The Constituency Constitutional Forum (CCF) was to run for an initial period commencing

November 2001 up to September 2002. Accordingly, each Constituency Constitutional Committee (CCC) should have been constituted at the very latest by the end of November 2001. The Constituency Constitutional Forum was to be operational by that time.

3.2. District Coordinators

3.2.1. Mandate/Terms of Reference

- Be the local grass root representative;
- Perform the generalization activities in the district;
- Be in charge of the documentation center/s in the district, facilitate its/their respective management, ensuring they are stocked and are easily accessible to the public and also organize their safety and security;
- Gathering any relevant local information and materials for the purpose of constitution making;
- Facilitate the identification, classification and organization of the physical and electronic retrieval and dissemination of information and materials for constitution making;
- Supply such information needed by local constituency forums and committees;
- Liaise with other documentation centers nearby and others for information;
- In collaboration with constituency committees, identify and arrange venues for public hearing whenever the CKRC visits the constituencies in their area;
- Facilitate regular meetings of the constituency committees and involve local people as much as possible in discussing constitutional issues;
- Source and identify other key personnel that the CKRC may wish to consult or engage in its work;
- Identify and arrange for simultaneous local translations, sign language users, procurement and hiring of public address systems, transport and communication facilities for CKRC's meetings in the district;
- Monitor the implementation of civic education by civic education providers in the district;
- Facilitate the formation of constituency committees with guidance and assistance of CKRC; and
- Perform any other tasks as directed by CKRC.

3.2.2. Criteria for Appointment

- Diversity in the composition, taking into account ethnicity, age, religion and professional or occupational background; and
- Appointees had at least attained Kenya Certificate of Secondary Education or its equivalent.

4. CIVIC EDUCATION

Civic Education in the constituency was carried out between 21st February 2002 and 22nd May 2002.

4.1. Phases covered in Civic Education

Stage one: - Is the only phase that was covered. This is the stage preceding the collection of views. This stage dealt with information, knowledge, skills and virtues that enabled Kenyans

have an informed choice and present their views on constitutional review.

5.3. Summary of Emerging Issues

The following are the recommendations made by the presenters in Mwala Constituency. The recommendations were collated around 43 areas of concern, from the Preamble to National integrity/identity. Only areas where recommendations were made in the constituency are covered. The numbers in parentheses represent the number of times the recommendation (bulleted) was made, either orally or through written memoranda. Each count on a specific recommendation was picked from an individual, a group or an organization. Where a presenter made different recommendations on the same area of concern, each recommendation was counted separately. Where no number appears in parentheses, the recommendation was made only once.

5.3.1 PREAMBLE

- The constitution shall have a preamble (13)
- The preamble should start with "We the people of Kenya..."
- The preamble should be simple and clear.
- The preamble should state that Kenya is a God fearing country.
- The preamble should express the Sovereignty of all Kenyans.
- The preamble should state that Kenya shall always be a democratic state.
- The preamble should spell out the broad socio-economic values of the Kenyan state.
- The preamble should establish a democratic constitution.
- The preamble should state that there shall be equal rights and opportunities for all.
- The preamble should express the vision aspirations and wishes of the people of Kenya.
- The preamble should embrace rights of the citizens.
- The preamble should capture the struggle for independence and national vision.
- The preamble should address culture and democratic principles.
- The preamble should capture the national vision and philosophy.

5.3.2 DIRECTIVE PRINCIPLES OF STATE POLICY.

- The constitution should provide that the law shall apply in a non-discriminatory manner to all Kenyans.
- .The constitution should provide that separation of state powers shall remain independent.
- .The constitution should provide that every Kenyan shall play his /her part in ending corruption.
- .The constitution should provide that there shall be democracy and condemnation of tribalism.

5.3.3 CONSTITUTIONAL SUPREMACY.

- The constitution should provide for its supremacy over all other laws in the country.
- The constitution should provide that a constitutional amendment shall only be through a public referendum.
- The constitution should emphasize that parliament shall not have the power to amend the constitution.
- .The constitution should provide that the constitution is subject to natural justice principles and not democracy.
- The constitution should be amended if parliament attains 85% majority in favour of the motion.

- The constitution should provide that amendment of the constitution shall be done by the people through referendums
- The constitution should provide that the percentage required by parliament to amend the constitution be increased to 75%.
- The constitution should provide that the constitutional shall be amended by the people and not parliament
- The constitution should be amended if parliamentarians attains 85% majority in favor of the motion.

5.3.4 CITIZENSHIP.

- The constitution should confer to all persons born of Kenyan parents automatic citizenship.(9)
- The constitution should provide for dual citizenship (9).
- The constitution should not provide for dual citizenship.
- The constitution should confer automatic citizenship to all persons legally married to a Kenyan citizen irrespective of gender.(7)
- The constitution should provide that a non-Kenyan child adopted by a Kenyan citizen shall automatically qualify for Kenyan citizenship.
- The constitution should provide that proof of citizenship shall be by way of National identification cards, birth certificates and passports.
- The constitution should provide that Muslims shall be Kenyan citizens.
- The constitution should stipulate that citizenship should be conferred on children born outside Kenya by Kenyan parents.
- The constitution should provide that all children born of at least one Kenyan parent be given citizenship regardless of gender or gender of the parent.(7)
- The constitution should provide for the protection of the citizens.
- The constitution should provide that Muslims be considered Kenyan citizens as their Christian counterparts.
- The constitution should stipulate that all Kenyan citizens shall have the right to acquire passports anytime they are 18 years old.
- The constitution should provide that all Kenyans shall carry a national identity card as proof of citizenship

5.3.5 DEFENSE AND NATIONAL SECURITY.

- The constitution should provide for the establishment of disciplined forces by the constitution (3)
- The constitution should provide that the president shall not be commander -in-chief of the armed forces (8)
- The constitution should provide that the president shall be Commander -in-Chief of the armed forces (8)
- The constitution should provide that the executive shall have exclusive powers to declare war
- The constitution should provide that extra-ordinary powers in emergency situation shall be invoked (4)
- The constitution should provide that parliament shall have pass all use of emergency powers
- The constitution should provide that police and prison officers shall be trained for a period of one year.

- The constitution should provide that ministry of Defense shall be headed by a Minister who will be in charge of all forces.
- The constitution should provide that no decisions affecting national policy on defense shall be made with the approval of parliament.
- The constitution should provide that after every three years all security officers should under go refresher courses and training.
- The constitution should provide that any organizations that poses a threat of insecurity to the citizens shall be deregistered.
- The constitution should provide that no officer shall receive bribe to protect.

5.3.6 POLITICAL PARTIES.

- The constitution should provide that political parties shall be involved in development projects (8)
- The constitution should provide broad guidelines for the formation, management and conduct of political parties (11)
- The constitution should provide that all political parties should have equal access to public premises and media especially for campaign purposes.
- The constitution should limit the number of political parties in the country to 2- 5.(16)
- The constitution should provide broad guidelines requiring that political parties have a national outlook..
- The constitution should provide that the government should not finance political parties. (5)
- The constitution should provide that the government should finance political parties.(11)
- The constitution should stipulate that all political parties should be registered without any conditions and after meeting the required standards.
- The constitution should provide for public funding of political parties as long as such parties have representation in parliament and have a demonstrable substantial following. The funding should be approved by the parliament.
- The constitution should provide that political parties and the state shall remain independent (8)

5.3.7 STRUCTURES AND SYSTEMS OF GOVERNMENT.

- The constitution should provide for a parliamentary system of government with a Prime Minister as the head of government. (5)
- The constitution should provide that the prime minister shall be head of government (4)
- The constitution should provide that the president shall be ceremonial (7)
- The constitution should provide for a parliamentary system of government in which the National Assembly chooses the Prime Minister.
- The constitution should provide for a government of National Unity composed of all parliamentary political parties.
- The constitution should provide that where a government of National Unity is formed, the nominee of the party with the majority of seats in parliament shall become the Prime Minister.
- The constitution should provide for a unitary system of government. (3)
- The constitution should provide for a unitary system of government with a ceremonial President and an executive Prime Minister.
- The constitution should provide for the strict observation of the doctrine of separation of power from Executive to Legislature.

- The constitution should provide that the three arms of the government shall have power to make provisions for a mini budget in cases of disasters
- The constitution should provide that Government offices shall be decentralized.
- The constitution should provide that NGO's should nominate a representative in the parliament

5.3.8 THE LEGISLATURE.

- The constitution should provide that in case of defection MP's shall not contest until the next general elections.
- The constitution should provide that an MP shall possess a degree from recognized university.
- The constitution should provide the Speaker shall have powers to dissolve Parliament and request the Electoral commission to organize for elections.
- The constitution should give Parliament power to impeach the president.
- The constitution should give Parliament power to vet and appoint all Ministers, Assistant ministers and Permanent secretaries.
- The constitution should give Parliament power to supervise the Judicial Service Commission and the Public Service Commission.
- The constitution should give Parliament sole power of approval of public expenditure as well as the salaries of MPs.
- The constitution should provide for an independent commission to decide on the salaries of MPs.
- The constitution should give Parliament power to control its own calendar.
- The constitution should provide that constituency boundary review shall be done every five years.
- The constitution should give parliamentary committees the power to prosecute.
- The constitution should give voters the right to recall non-performing MPs by way of petition, referendum or collection of a required number of signatures from the MPs constituency.
- The constitution should provide that there shall be equal representation of all constituencies.
- The constitution should provide that a parliamentary aspirant shall be a Kenyan.
- The constitution should provide that MPs have public offices in their constituencies.
- The constitution should provide that constituencies shall have 20,000 constituents
- The constitution should provide that nominations in parliament shall only be reserved for special interest groups and the vulnerable groups.
- The constitution should provide that the legislature should involve the mwananchi in the process of law making.
- The constitution should provide that MP's salaries shall be reduced.
- The constitution should provide that MP's shall have opportunities to visit constituents.
- The constitution should provide that children shall be represented in parliament
- The constitution should provide that a Members of Parliament shall work full time.
- The constitution should provide that an MP shall have attained at least 19 years of age.
- The constitution should provide that MP's shall not compute their own salaries.
- The constitution should provide that parliament shall have unlimited powers to control its affairs through standing orders.
- The constitution should provide that the budget should be made available to all MP's 3 months before it is read for scrutiny and pre - budget negotiations

- The constitution should provide for the full participation of MPs in the preparation of the national budget at all stages

5.3.9 THE EXECUTIVE.

- The constitution should provide for a ceremonial president who should not belong to any political party and should be elected by popular vote.
- The constitution should provide that all presidential candidates declare the source of their wealth.
- The constitution should provide that the president shall appoint his running mate and they shall not be members of parliament.
- The constitution should provide that the president shall be subject to the law.
- The constitution should limit the powers of the president.
- The constitution should provide that the president shall not have the power to dissolve parliament.
- The constitution should limit the duties of the president to that of Commander in Chief of the armed forces and appointment of cabinet ministers..
- The constitution should provide for the impeachment of the president.
- The constitution should provide that the president should serve a maximum two five year terms.
- The constitution should provide that all presidential appointments be vetted by parliament.
- The constitution should provide a minimum qualification of a university degree for a presidential candidate.
- The constitution should provide that the president must be between 30 - 55 years of age.
- The constitution should provide that the president should not have power or authority to dissolve parliament.
- The constitution should provide that the president should not be a member of parliament.
- The constitution should provide that the Vice President be directly elected by popular vote.
- The constitution should provide for appointment to the cabinet through merit.
- The constitution should make provisions for the overhaul of the provincial administration to ensure its efficiency.
- The constitution should abolish the provincial administration structure of government.
- The constitution should provide that the provincial administration be abolished and its role should be taken over by the local government.
- The constitution should provide that the Chief and the Assistant Chief be elected by popular vote by members of the respective administrative location.
- The constitution should provide that the President should be above party politics and not a Member of Parliament.
- The constitution should provide that the Executive should comprise of the Prime Minister, the Ministers, the Deputy ministers and the Permanent Secretaries all of whom shall be liable to impeachment.
- The constitution should provide that women shall be nominated to the cabinet
- The constitution should provide that the vice president shall be elected by the people
- The constitution should provide that provincial administration shall be open to both gender.
- The constitution should provide that PC's shall be elected by parliament.
- The constitution should provide that the offices of P.C's, D.C's, and D.O's be scrapped.
- The constitution should provide that the offices of provincial administration shall be

retained.

- The constitution should provide that village headmen shall be paid by the government
- The constitution should provide that chiefs shall be elected by the people
- The constitution should provide that any person-seeking presidency shall be a Kenyan citizen.
- The constitution should provide that the prime minister and not the president shall be the Commander in Chief of the Armed forces.
- The constitution should provide that the president shall not have powers to declare war.
- The constitution should provide that appointment of ministers shall be done on merit and the minister should be qualified.
- The constitution should provide that there shall be no restriction on the marital status of the president.
- The constitution should provide that a president shall be aged between 35 and 70 years.
- The constitution should provide that a president shall not be above the law.
- The constitution should provide for a creation of the prime minister's office that will share powers with the president.
- The constitution should provide that the president shall be the head of state.
- The constitution should provide that the President and the Cabinet shall appoint ambassadors only after consultation

5.3.10 THE JUDICIARY.

- The constitution should provide for the independence of the judiciary.
- The constitution should provide for a permanent constitutional court.
- The constitution should provide for the independence of private prosecutors.
- The constitution should provide that appointment of judges should be approved by two thirds of the Members of Parliament.
- The constitution should provide that illicit brews and drugs are banned.
- The constitution should provide for a levy- free access to judicial service.
- The constitution should provide for a Judicial Commission elected by the people to oversee the functioning of the Judiciary.
- The constitution should provide for establishment of law courts at constituency levels.
- The constitution should provide that children courts shall be established
- The constitution should provide that the Attorney General shall be supreme and independent.
- The constitution should provide for security of tenure for judges.
- The constitution should stipulate that application and filing fees should as much as possible be pegged at a rate affordable to the common person.
- The constitution should provide that justice would be upheld.
- The constitution should stipulate that the Judicial service Commission with the approval of the Parliament should appoint Judges.
- The constitution should provide that the appointment of Judicial Service Commission shall be done by Parliament.
- The constitution should provide that Parliament should appoint the Attorney General with the help of the Law Society of Kenya.
- The constitution should stipulate the period that a case in court should take.
- The constitution should provide that
- The constitution should provide that rape cases shall attract stiff penalty.
- The constitution should provide that abortion shall be criminalized.
- The constitution should provide that the Judiciary shall be independent.

- The constitution should provide that the Judiciary shall administer justice and stiff penalty for offences involving drug abuse.
- The constitution should provide that Prostitution shall be outlawed.
- The constitution should provide that the undisciplined forces shall be prosecuted in ordinary Law courts.
- The constitution should provide that Kadhi courts are abolished.
- The constitution should provide that death sentence is abolished

5.3.11 LOCAL GOVERNMENT.

- The constitution should provide that all elective positions in the local government, including the position of the mayor and the chair of the Country Council, be filled by direct popular elections.
- The constitution should provide that all local authority by-laws be adopted by way of a referendum.
- The constitution should provide that Mayors and Chair of County Council serve a maximum two five-year terms.
- The constitution should stipulate that county clerks, town clerks and municipal council clerks shall be registered lawyers.
- The constitution should provide for the funding of Local authorities by the central government.
